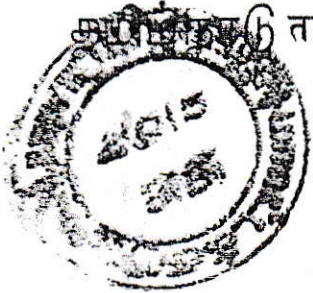

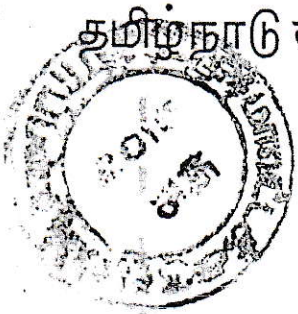

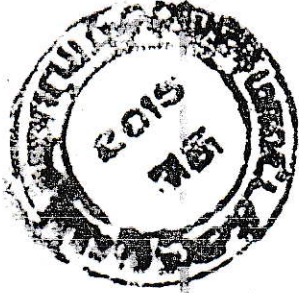

(c) The **SECRETARY OR TREASURER** to receive and keep all trust funds and monies by way of gift, donations, contributions, borrowings and grants all over the world and other assets for the trust. To invest the moneys of the Trust in any of the securities authorized by the Indian trust act 1882, in accordance with the provisions of the Income Tax Act 1961.

(d) The **SECRETARY OR TREASURER** to invest the funds in lands, Buildings and other equipments and accessories necessary for the furtherance of any or all the objects of the Trust.

(e) The **SECRETARY OR TREASURER** shall have the power to open bank accounts in the name of the Trust in any Nationalized Banks or in any other banks and to operate the same.

(f) The **SECRETARY OR TREASURER** shall have the powers to appoint staff and employees to carry out the objects of the Trust, when-ever necessary, and to terminate if necessary.

(g) To invest its funds in Government stock certificates. Promissory notes and securities and may purchase, sell, endorse, transfer and negotiate such Government stock certificates, promissory notes or securities and also cheques.

(h) To purchase, sell, endorse, transfer and negotiate government stock certificates, promissory notes or Government securities in the name of the Trust and to collect the interest due thereon.

(i) To borrow or raise money in such manner as the Trust shall think fit and to secure the repayment of any moneys borrowed or raised charge or lien upon the whole or any part of the Trust's property or assets and to give to lenders or creditors powers of sale and all other usual and necessary powers. All the above activities should be done only with the concurrence or ratification of the Board of Trustees.

It is hereby expressly declared that the Trust is absolute and irrevocable.

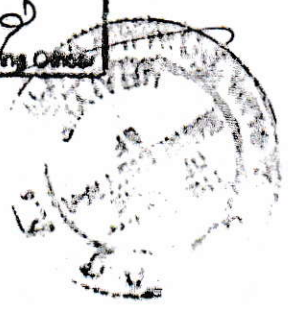




